Opening of Reign XXVI

President Ray opened up with letting the new Monarchs know that the Board will be there to assist and that we are a working Board and not to hesitate to reach out for assistance. Ray will also be attending the Board meetings for ABQ Pride and SOCH.

Reign Goals

- Plans and Expectations
 - First quarter has been planned and figured out to include investitures, fire and ice, and SPOY. Softball will be left for the next quarter along with Holiday drive. First 3 fundraisers will be going to RAICES including the show on the June 29th. Donations from the car wash on the June 23rd and Drag Bingo on June 30th. Although this was not an official Reign charity it was one of importance given the current state of affairs.
 - Emperor Jose Ogaz Munoz
 - Charities and focus will be on the Yolanda Acosta fund, New Mexico Cancer, and any organizations doing work with HIV awareness and prevention. The Emperor would like to review the process for the emergency fund and add a requirement from the requestor to write a statement about how this assistance will impact their life. This is meant to help promote and grow the fund. Robert offered the suggestion of leveraging these stories with the Membership Newsletter that he has been thinking about starting up. He is also shooting to have Nicole the Great in attendance for Coronation.
 - Empress Estevan Zamora
 - Reign retreat 21st and 22nd of July immediately following Investitures and will be at the Santa Fe Mountain Center. Majority of potential Investees will be in attendance. The Charities TGRC, Sane, The Womens Resource Center of New Mexico, Young Womens United. These are to follow along with her campaign goals and will be primary focus for the Empress. Would also like to involve Tony Medina in more of the fundraisers like what he did for the travel fund. Possible do fall fundraiser and auction a New Mexico basket. These will be separate from the normal reign fundraising.

- Board Duties
 - Board Member commitments were handed out and reviewed by each Board member explaining that we will keep the UCS at heart in all our interactions. These will be in place of non-disclosure agreements since those conflict with the transparency that we need to have. Each member signed these and will be held on file until end of the Reign.
- Board Retreat will be setup to be able to discuss big event items and reign expectations. Ray will send out a doodle so we can pin down what dates will work for everyone.
- Membership Discussion
 - Currently membership is limited to our lifetime titles but a motion would need to be made to have our paid memberships back and have a 2 tiered membership that allows community members to have voting rights for elections only and paid membership to have additional perks and access to vote on UCS policy and procedures. The rewrite of PNP's does have a detailed plan for membership. We will have this as an item for the next Board Meeting.
- Distribution of UCS Property and passwords
 - Forms have been prepared for what property and items will be issued out to each Board member. These will be updated as well once all property has been returned and redistributed including passwords to the website/Email and financial accounts.
 - Ray mentioned that he would like to add all Board members to the College of Monarch chat so that an open communication can be done between both groups. Due to some hesitation it is recommended that Ray reaches out to the College to see what their input is on this prior to anything being done and will discuss at the next meeting.
